Application information:

Smoothing agent must not remain on the sealant joint and on adjacent surfaces, because dried residual sealant might cause optical impairmentes (dull/light spots).

As a matter of principle it is advisable to use the smoothing agent as sparingly as possible, for example by only slightly moistening the smoothing tools or applying the smoothing agent directly to the surface of the sealant with a clean paintbrush.

Residual smoothing agent must be removed using clear water before it dries.

Otherwise stains and discolouring can not be excluded completely due to the special consistency of natural stones.

**PLEASE NOTE:** On very sensitive natural stones (e. g. Nero Impala or Nero Assoluto) the use of OTTO Marble Silicone Smoothing agent and other smoothing agents can lead to stains and discolourings which cannot be removed with commercial detergents.

When tooling off the matt finish with OTTO Marble Smoothing Agent - please be aware: The joint should be tooled off once, with a smoothing tool emmersed in OTTO Marble Smoothing Agent. Do not make too many repeat passes with the smoothing tool to avoid polishing the matt surface!

5 I and 10 I canisters are equipped with "Anti-bubble system".

Due to the many possible influences during and after application, the customer always has to carry out trials first.

Please observe the recommended shelf life which is printed on the packaging.
